In her international arbitration practice, Ruzin represents individuals, companies, States and State-owned entities in international disputes conducted under the LCIA, ICC, DIAC, SCC, UNCITRAL and ICSID rules across a variety of sectors, including construction, energy, infrastructure, technology, pharmaceuticals and textiles. Ruzin also advises States and international organisations on public international law matters such as the application of treaties, dispute resolution issues relating to international trade and investment, human rights and sovereign immunity.

In her commercial litigation practice, Ruzin advises both individuals and companies in matters before the English High Court, including in complex shareholder disputes, disputes involving family businesses, debt collection and insolvency issues and litigation ancillary to arbitration proceedings, such as the enforcement of arbitral awards.
